VCDC Offices Going Mobile as part of Downtown Boom

Vermilion, SD, Mar. 28th, 2018 - Vermillion will welcome another exciting new business to town in 2018. Beginning May 1, 2018, the office that currently houses the Vermillion Area Chamber of Commerce and Development Company (VCDC) will have a new tenant for years to come. 116 Market Street will now be home to Heartland Psychological Services. Having operated their current business in Yankton for a number of years, this move represents an expansion of their services. "Not only are we honored to be able to restore a beautiful, historic, downtown building but we are beyond excited to bring our community a new and dynamic space for creative collaboration, with a focus on economic development and tourism." says Nate Welch, President & CEO of the VCDC.



Beginning May 1st, the VCDC will begin their mobile operations for the duration of the renovation.
